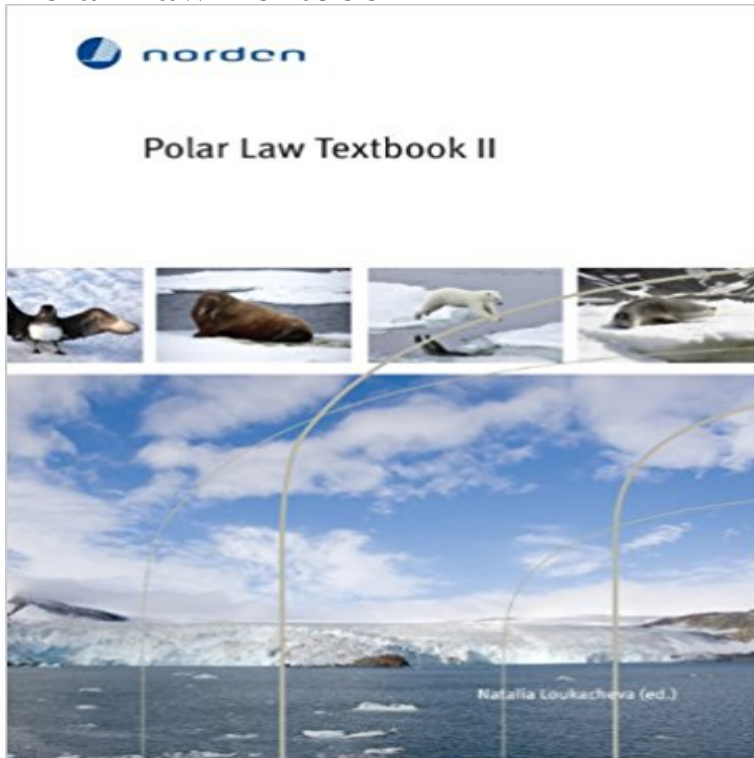


# Polar Law Textbook II
